- III. **AMENDMENTS TO AGENDA:** Chief Plakos moved to approve agenda with one item, discussion of Rosenbauer engine financing, added. The motion was approved unanimously.
- IV. APPROVAL OF PREVIOUS MEETING MINUTES

- A. Treasurer's report: No budget reports were reviewed as there have been no changes since the last meeting. A memo from Sonoma County has been received documenting the progress towards obtaining "backfill" funds for property taxes lost due to the 2017 wildfires. Once this occurs NSCFPD should receive backfill of about \$25,000. It is not clear whether this will happen this year or next.
- B. Review draft of audit report: The draft audit report was reviewed; questions and issues were collected and will be sent to the auditor and bookkeeper by Chief Plakos.
- C. Update from the investment sub-committee: Ms. Campbell reported that the sub-committee has no report yet but was glad to be referred to the CSDA investment funds for government agencies, which looks promising.
