I. CALL TO ORDER: The meeting was called to order at 10:06 a.m.

- V. PUBLIC COMMENT ON NON-AGENDA ITEMS: None
 - **A. CONSENT CALENDAR:** A motion was made to approve the consent calendar by Dir. Nybakken, 2nd by Dir. Tittle, and approved by a vote of 4-0 (Dir. Gardener had not yet arrived at the meeting).

VFA Liaison: both the regular meeting and the annual meeting occurred last week; the North Fire Station plans were reviewed, the biological resources plan is underway; 2 board members stepped down, and 2 new ones took their places on the board; review of what the VFA is spending on scholarship, asphalt replacement at North Fire Station, roof work, various apparatus, NFS expansion plans, uniforms; officers will be elected at next meeting.

- A. **CAL FIRE 2023 Volunteer Fire Capacity Grant:** A motion was made to accept the resolution, authorize signing of the grant agreement and execution of the grant program by Chief Plakos (Resolution 24-08) by Dir. Tittle, 2nd by Dir. Gardener, approved by vote of 5-0.
- B. **Final Budget:** A motion was made to approve the final FY24-25 budget (Motion 24-09), with the addition of increasing the expected sales tax revenue as predicted by the county, and increasing the amount for the District Administrator salary and expenses by Dir. Gardener, 2nd by Dir. Tittle, and approved by a vote of 5-0.
- C. **VFA MOU:** A motion to approve updated Memorandum of Understanding document between NSCFPD and The Sea Ranch Volunteer Fire Department, Inc (Motion 24-10) was made by Dir. Nybakken, 2nd by Dir. Gardener, and approved by a vote of 5-0.
- D. **DA Onboarding:** The plan for bringing the new District Administrator on-board was discussed.
- E. **Board Retreat:** The content and participants in a future board retreat was discussed, including suggestions for moderation, and possible participants such as the VFA board.
